# **PROGRAM NOTES**

Saint Saens Sonata for Clarinet and Piano: Saint-Saens was a French composer, pianist, and conductor. Op. 167 was written in 1921 by Camille Saint-Saens. The piece was published with four movements. Sonata for clarinet and piano is considered "standard repertoire" and is highly respected for its elegance, beauty, and immaculate construction. The opening melody in the first movement immediately establishes the expressive and lyrical contents of the following movements. The second movement provides a more cheerful and upbeat mood in direct contrast with the sorrowful third movement proceeding. Arabesque:Germaine Tailleferre was a French composer and the only female woman of a group of composers called Les Six. Arabesque was written in 1973 and is one of only two solo works for clarinet written by the composer. Arabesque is short but sweet and lyrical. The piece provides a whimsical melody that is persistent throughout the entire piece. Written in E flat major, the piece provides the soloist with challenging register jumps that require complete control of air and the instrument from the clarinetist.

Clarinet Duet (Based upon the Sonata in C K. 296): Wolfgang Amadeus Mozart was an Austrian composer. He composed works in several genres such as operas and symphonies. He was a well-recognized composer and wrote many famous and recognizable works. Clarinet duet was written in 1778 and was originally written for violin and piano but was later transcribed for several other instruments, including the clarinet. The first movement is fast paced and in the key of C major. Canzonetta for Clarinet and Piano:Gabriel Pierne was a French composer. Conzonetta for Clarinet and Piano was written in 1888 when the composer was only 25 years old. The melody is wistful and full of arpeggios played by the clarinet soloist. There are 3 distinct yet flowing sections in this piece, the melody being heard in both the piano and clarinet at alternating times. The ending provides a challenge for the soloist because it is beautiful if played well, having a 3 octave jump on F to finish.

Three Preludes: George Gershwin was among one of the most famous and influential American composers during the 20th century. He wrote many famous works for the clarinet, including his Three Preludes and Rhapsody in Blue. Three Preludes was written in 1926 and is a collection of three jazzy movements. The second movement features the A clarinet, which is a half-step lower than the B flat clarinet. The movement is slow and bluesy in E minor. The soloist has creative liberty to make this piece their own and is perfect for a clarinetist that is not used to jazz.
