**Summa**

A committee member is satisfied that the project is of the highest level of research, analysis, writing, or performance, when applicable, and is of the caliber to be presented at a regional or national conference; or submitted to a journal in the field; or performed or displayed in the venue appropriate to the specific artistic discipline.

**Magna**

A committee member is satisfied that the project is a carefully researched, well-written, analytical (not simply descriptive) or presented/preformed project that assesses the significance of the research an or artistic discipline involved.

**Cum**

A committee member is satisfied that the project is worthy of honors and that corrections that need to be made are minor.

**No Honors**

If any committee member finds that the project is inadequate and feels that no honors should be awarded, the Honors Council will make a final determination on the student's status.

Each committee member will assign the student a level of distinction for the honors thesis/defense. The Honors office will average those levels, and this number, along with the student's GPA and number of honors hours, will be used by the Honors Council to determine the student's ultimate level of graduation. To graduate at a specific level, the student must meet all three minimums (GPA, number of honors hours, and defense score) set by the Council for that level.

**Note:** the cumulative GPA from the semester *before* the student's final semester (semester of graduation) will be used in determining the student's GPA. For example, the GPA at the close of the Fall semester will be used for Spring graduates, since the Honors Council must determine the student's distinction before final grades have been submitted in the Spring.
